Re: Your child's flu vaccination

Dear Parent/Carer,

We have now visited your child's school to deliver Influenza (flu) vaccinations.

If you missed this opportunity and would like your child to have this vaccination, please complete the e-consent by visiting www.surreyimmunisations.co.uk and entering your schools unique code SR136338 .

You will then receive an invitation to book into a community clinic of your choice.

- If **you do not want your child to receive a vaccine, then please fill in the 'No'** box.
- If you do not want your child to receive the nasal spray vaccine on the basis of porcine gelatine, please fill in the **'No'** box indicating this, and you will be given the opportunity to consent for an alternative vaccination. This vaccination is delivered by injection into the arm (intramuscularly) and does not contain any porcine DNA agents.

An automated email will be sent to you on completion of the e-consent form from school.immunisations@nhs.net (who host the website portal for us). If you do not receive this, please check in your junk email or contact the Immunisation team.

GDPR

On the 25 May 2018 the new EU General Data Protection Regulation (GDPR) came into force bringing with it improvements to Data Protection Regulations. Article 6 (1) (e)

For the performance of a task carried out in the public interest or in the exercise of official authority.

Article 9(2)(h)

Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.
